

# **Temple Disc Golf Association**

## **By-Laws**

### **Article I: Name**

The name of the association shall be the Temple Disc Golf Association, herein referred to as the Association.

### **Article II: Objective**

The Association consists of citizens of Temple, Texas, members at large residing outside of Temple and other individuals who volunteer their time to provide and educate the community about Disc Golf. This association also has monthly mini-tournaments for the community to participate in. All monies collected are to be used toward the courses in Bell County, Texas and to use as awards to the citizens that attend these tournaments as prize money. This money also assists with the upkeep of these courses (i.e. signs, baskets, tee boxes, etc.).

### **Article III: Officers**

### **Article III: Officers - Amendment**

The Association shall elect officers from their own active membership. The President and Vice President will be elected annually on a calendar year basis. Officers will be elected at the December Election meeting and will take office on January 1<sup>st</sup> of the next calendar year.

**PRESIDENT:** The President shall preside over all meetings. The President will have access to club funds and distribute these funds according to the wishes of the Association. The President is also responsible for any other duties necessary to maintain a successful Association. The President is expected to take interest in all fundraising activities of the Association, being certain that someone is in charge of the event and that there is ample people power available and present at the event. The President will only vote in case of a tie. The President's vote will be final.

**VICE-PRESIDENT:** The Vice-President is in a position to take responsibilities of the President in his/her absence. Should the President wish to resign or retire, the Vice-President shall assume the responsibilities of President. The Vice-President shall reside over meetings in the absence of the President. The Vice-President shall also take a

personal interest in all fundraising and course improvement activities and assist the President making sure there is ample people power available and present during these activities. The Vice-President will also help with course construction and Maintenance projects as needed.

#### **Article IV: Meetings**

The Association shall hold meetings on a quarterly basis. Special meetings may be called as deemed necessary by the Association Officers. Two thirds of voting members present will be considered a quorum for each meeting. In the event of a tie the President will be allowed to vote to break the tie.

#### **Article V: Memberships**

Membership is open to any individual who is interested in supporting the Temple Disc Golf Association Community. Individuals with a paid membership of \$25.00 will have voting rights only. One vote per individual. Membership fees are due by the January meeting of each calendar year. Each paid member will receive a T-Shirt, Koozie Cup, and Bag Tag. Any person paying in June or later will pay a prorated amount of \$10.00. This prorated membership will be good from the paying month until December 31<sup>st</sup> of the calendar year. This prorated membership will receive a Bag Tag but will not receive a T-Shirt or Koozie. Any person paying membership October or any month thereafter of the calendar year will pay the full membership amount and this membership will be continued through the next calendar year. These memberships will receive a T-Shirt and Koozie but will not receive the Bag Tag until the beginning of the next calendar year.

Membership fees will be put into the account to use towards tournaments held through out the year. These funds will assist in purchasing discs, shirts and other needed items for use in awarding the attendees of the tournaments. It will also assist in purchasing items needed for the upkeep of the courses when needed and also any other club expenses.

Any paid member with a Bag Tag will be able to challenge other members throughout the calendar year for a lower Bag Tag. Members with Bag Tags who participate in the Mini Tournaments are required to be included in the Tag Challenge for that Mini. In the spirit of good sportsmanship, members should try to participate in the monthly tournaments so that their Bag Tag can be included in the Tag Challenge. In the event that a member cannot participate in the Minis they should relinquish their Bag Tag for a higher number tag.

#### **Article V: Memberships - Amendment**

Membership is open to any individual who is interested in supporting the Temple Disc Golf Association Community. Individuals with a paid membership of \$20.00 will have voting rights only. One vote per individual. Membership fees are due by the January meeting of each calendar year. Each paid member will receive a T-Shirt, Custom Mini marker, and Bag Tag. Any person paying in June or later will pay a prorated amount of \$10.00. This prorated membership will be good from the paying month until December 31<sup>st</sup> of the calendar year. This prorated membership will receive a Bag Tag but will not receive a T-Shirt or Custom Mini marker. Any person paying membership October or any month thereafter of the calendar year will pay the full membership amount and this membership will be continued through the next calendar year. These memberships will receive a T-Shirt and Custom Mini marker but will not receive the Bag Tag until the beginning of the next calendar year.

Membership fees will be put into the account to use towards tournaments held through out the year. These funds will assist in purchasing discs, shirts and other needed items for use in awarding the attendees of the tournaments. It will also assist in purchasing items needed for the upkeep of the courses when needed and also any other club expenses.

**Article VI: Committee**

The President has the responsibility of appointing committees made up of active members. The President shall appoint and the Association will elect special committees as necessary. Committees shall meet and then present their findings to the club for approval. If at any time a committee fails to complete the task assigned, a new committee will be set up if time allows. If no time is allowed, the club officers will then take necessary actions to complete the assignment or make a decision.


**Article VII: Amendments**


Amendments to the Temple Disc Golf Association bylaws may be submitted to the Association at any time to be voted on by members.
